Important Information about this Training

PDEP is a program for parents/caregivers aimed at strengthening relationships, promoting healthy development, and preventing violence against children. The program has recently been updated to integrate the most current information on children's emotional, cognitive, sexual, gender and brain development, and has been completely revised through a trauma-informed lens.

These PDEP Facilitator Trainings are among the first in the updated program. They are part of an initiative funded by the Public Health Agency of Canada to disseminate trauma-informed PDEP to parents/caregivers across the country. These Trainings will be delivered in English, but bilingual individuals are encouraged to apply as materials will become available in French in the next phase of the project.

The program is delivered in person, to groups of 10 to 14 parents/caregivers. It consists of 9 weekly 2-hour sessions. **In order to participate in this training, you must be able to deliver the PDEP program to a group of 10 to 14 participants beginning within 3 months of the training.**

You must also be able to participate in 3 online post-training support sessions with a Trainer. These 1-hour meetings will be scheduled: 1) before you start delivering your first program, 2) mid-way through your first program, and 3) soon after your first program ends.
